On Wednesday, April 17th, the HOA sponsored a FREE event, "Coffee with a Cop", with 27 residents attending. Coffee, juices and pastries were provided. Hernando County Sheriff, Al Nienhuis, along with a number of Deputies and support staff, gave a very good presentation, complete with a Q&A session. Residents who attended the event appeared to enjoy it and were impressed with the Sheriff's Department's understanding of the issues we all face each and every day.

The presentation took just over an hour and covered various departments and functions, crime concerns, traffic conditions, and the housing growth around us. The Sheriff provided general details on the various departments under his authority, and how each plays a role in maintaining safety in our County. Our residents asked a number of good questions, which received equally good answers. After the formal presentation was done, the Sheriff, Deputies and staff stayed to informally discuss any other concerns, and just 'shoot the breeze.'

The Sheriff noted, if anyone is interested in finding out further details of the Department, he strongly recommended to attend the "Citizens Academy". This is a free, 9-week program, held at the Sheriff's office, Emergency Communications and Operations Center located at 18900 Cortez Blvd, Brooksville. During the HOA sponsored "Coffee with a Cop", one of the many items presented by the Hernando County Sheriff, Al Nienhuis, was the Department's **Neighborhood Watch** program. The Sheriff spoke specifically about the two developments to the south and north of us, either already started or coming soon. To use his words: "*with that type of development, you can be sure there will be nefarious characters there.*" We all have a concern for our quality of life and security. With that common desire, we need to ask ourselves **IS IT TIME TO FORM A NEIGHBORHOOD WATCH**? Think it over. We need to have a team in place before these developments are selling houses. This type of group takes time to properly organize. We can use the summer to start planning, and in the fall, when our part-time residents return, continue the process with them included.

**PLEASE NOTE: THIS IS NOT A LAW ENFORCEMENT FUNCTION OR OPERATION.** It is an organization of neighbors watching out for neighbors, with the Sheriff's Department training, knowledge and instructions on how to quickly and efficiently contact our County First Responders. It is very important to know, this is an on-going commitment. We will need a minimum of 8 to 10 people to start, but the more we have, less the burden on everyone.

Sheriff's office for those that live alone and those who would like to have daily telephone contact with a clerk who cares. (This information is taken directly from the www.hernandosheriff.org website. There is more information available there).

"To participate in the CARE LINE program, one must complete an application. The application, properly completed, also serves as an agreement to comply with the procedures necessary to make the program successful. A waiver is included as well. When signed, the waiver authorizes a Hernando County Sheriff's deputy to make forced entry (if no key is available) into a residence to check the well-being of the client. There is NO COST to participate."

1 teaspoon salt
1/8 teaspoon ground cayenne pepper

- 2 (15 ounce) cans black beans, rinsed and drained
- $1 \frac{1}{2}$  cups frozen corn, that
- 1 avocado, peeled and pitted, diced
- 1 red bell pepper, chopped
- 2 tomatoes, chopped
- 6 green onions, thinly sliced
- $\frac{1}{2}$  cup cilantro, chopped

#### **Directions:**

- 1. In a small jar, add the olive oil, lime juice, garlic, salet, and the cayenne pepper.
- 2. Close the jar's lid tightly and shake it until the dressing is well-combined
- 3. In a large salad bowl, combine the beans, corn, avocado, bell pepper, tomatoes, green onions and cilantro.
- 4. Pour the dressing over the salad and toss to coat.
